The Fund is designed for investors who seek a high level of income, stability of principal, and to maintain liquidity.

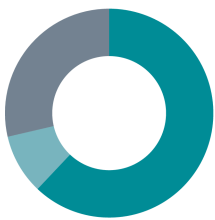
## Investment Criteria

## Asset Allocation (As of 6/30/23)

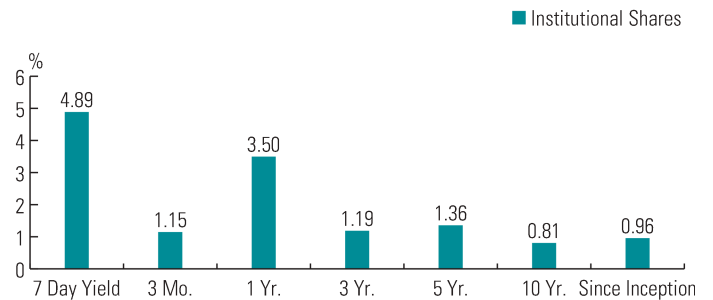
