
#### **Durable Credits**



Credit Quality letter ratings are provided by Standard and Poor's, Moody's, and Fitch and are presented as the higher of the three ratings. When a security is not rated by Standard & Poor's, Moody's, or Fitch, the highest credit ratings from DBRS and Kroll may be used. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.

The BBH Income Fund was rated against the following number of Intermediate Core-Plus Bond category funds over the following time periods: 552 funds in the last three years and 518 funds in the last five years. With respect to these Intermediate Core-Plus category funds, the BBH Income Fund (Class I), received an Overall Morningstar Rating of 5 stars. Class I three and five-year periods received ratings of 5 stars and 5 stars, respectively.
