Monthly Fund Update / July 2023

The BBH Income Fund Class I ("the Fund") returned 0.34% in July, and the Bloomberg U.S. Aggregate Index returned -0.07%.

U.S. Treasury rates rose slightly across all tenors during July. The Federal Reserve (Fed) met on July 26th and raised the target range of the federal funds rate by 0.25% to 5.25%-5.50%. The Fed's next announcement is scheduled for September 20th. In addition, the Fed continues its campaign of shrinking its portfolio of assets acquired through open market operations by a maximum of \$95 billion.

Performance of shorter duration benchmarks gained during the month while longer duration, investment-grade fixed income benchmarks were negative as interest rates rose. Risk spreads narrowed across all credit sectors, qualities, and instruments. Agency mortgage-backed securities (MBS) outperformed Treasuries during the month despite the Fed's waning support and its extended duration. Longer duration corporate bonds notably outperformed. High yield

corporate bond, bank loan, asset-backed securities (ABS), and commercial mortgage-backed securities (CMBS) indexes outperformed Treasury alternatives.

Sector allocation drove the Fund's outperformance in July, as the Fund emphasized stronger-performing segments of the credit markets, including investment-grade corporate bonds, senior bank loans, and ABS. Security selection contributed further to relative results, as the Fund experienced favorable results from its holdings of CMBS, investment-grade corporate bonds, and high yield corporate bonds. The avoidance of agency MBS detracted from performance.

We found several attractive opportunities for the Fund despite weakening valuations. We purchased corporate bonds issued by a transportation services company, a senior bank loan to a midstream energy company, and bonds from a billboard assets ABS deal.

"Proceed with caution" might be an apt summary of our generic advice for credit investors. As we look ahead, the importance of bottom-up selection is as evident as ever.

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
