

BBH Intermediate Municipal Bond Fund

Monthly Fund Update / February 2023

The BBH Intermediate Municipal Bond Fund Class I ("the Fund") returned -1.91% in February, and the Bloomberg U.S. 1-15 Year Muni Blend Index returned -1.88%.

Interest rates rose in February as market predictions for the pace of Federal Reserve (Fed) tightening increased due to reports of strong nonfarm payrolls and stubbornly high inflation. Investors added another \$1.6 billion to municipal funds in February, bringing net year-to-date flows to \$9.7 billion. Despite the February inflows and a light issuance calendar that saw net supply decrease by \$5 billion, municipal spreads widened during the month.

As valuations improved, we sourced several attractive purchases for the Fund. These opportunities included bonds issued by the Illinois Housing Development Authority, school districts in San Diego, California and Multnomah County, Oregon, industrial development revenue bonds by SeaTac Fuel Facilities (Washington), prepaid natural gas bonds backed by Citigroup, and NorthShore University HealthSystem (Illinois).

We remain focused on durable credits¹ that can control their own destinies and protect their market access. We believe this focus has increased importance as the Fed fights inflationary pressures and pushes the economy toward a potential recession. We own these credits to help preserve the value of our clients' portfolios, and our patience allows us to take advantage of opportunities generated by investor uncertainty.

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The BBH Intermediate Municipal Bond Fund was rated against the following numbers of Muni National Interim category funds over the following time periods: 283 funds in the last three years and 246 funds in the last five years. With respect to these Muni National Interim category funds, the BBH Intermediate Municipal Bond Fund (Class I & Class N), received an Overall Morningstar Rating of 3 stars and 3 stars, respectively. Class I three- and five years periods received ratings of 4 stars and 3 stars, respectively. Class N three- and five-year periods received ratings of 3 stars and 3 stars, respectively.
