## BBH Intermediate Municipal Bond Fund

Monthly Fund Update / January 2023

The BBH Intermediate Municipal Bond Fund Class I ("the Fund") returned 2.51% in January and the Bloomberg 1-15 Year Muni Blend Index returned 2.25%.

Interest rates declined in January as market predictions for the pace of Federal Reserve ("Fed") tightening eased. Municipal fund flows continued to influence valuations. Investors added \$5.3 billion to municipal funds in January, and combined with low levels of supply, drove both yields and spreads lower.

Despite challenging valuations, we sourced several attractive purchases for the Fund during the month. These opportunities included bonds issued by State Housing Finance Authorities in North Dakota and Missouri, a revenue bond issued by Southern California Edison Company, and prepaid natural gas bonds backed by Citigroup.
