

BBH Limited Duration Fund

Monthly Fund Update / August 2022

The BBH Limited Duration Fund Class I ("the Fund") returned 0.12% in August, and the Bloomberg U.S. 1-3 Year Treasury Bond Index returned -0.80%.

Treasury rates rose during the month. Federal Reserve ("the Fed") Chairman Jay Powell stated at the economic policy symposium in Jackson Hole, WY that the Fed is committed to restoring price stability through more restrictive monetary policy. Market expectations revealed the increasing probability of a more-aggressive, hawkish action following these remarks. The Fed continued to reduce the size of its balance sheet, and the pace will accelerate to a maximum monthly decrease of \$95 billion per month starting in September. In addition to monetary policies, fiscal policies were passed in August that will impact the economy in a variety of ways. The Inflation Reduction Act and the Student Loan Forgiveness plans will impact certain credits both positively and negatively, although we do not hold any significantly impacted credits, such as student loan asset-backed securities (ABS). Nor have we observed significant changes to credits owned in the Fund.

Agency mortgage-backed securities (MBS) underperformed Treasury alternatives as mortgage spreads widened, perhaps due in part to the Fed's waning purchases. The corporate bond market outperformed Treasuries as credit spreads declined during the month. High yield loans gained 1.5% despite the broad rise in rates.

The Fund's outperformance was driven by its positioning in corporate and structured credit. Corporate credit allocations were a contributing factor with an allocation to loans, an overweight to corporate bonds, and favorable selection results. The Fund's positioning in ABS and commercial mortgage-backed securities (CMBS) impacted results favorably as well.

Credit valuations remain attractive and offer more opportunities to find durable credits¹ at attractive yields. We remain measured, selective, and patient in evaluating these emerging opportunities.

While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The BBH Limited Duration Fund was rated against the following numbers of U.S.-domiciled Ultrashort Bond category funds over the following time periods: 215 funds in the last three years, 178 funds in the last five years, and 94 funds in the last ten years. With respect to these Ultrashort Bond category funds, the overall BBH Limited Duration Fund (Class I & Class N), received a Morningstar Rating of 5 stars and 5 stars, respectively. Class I three-, five- and ten-year periods received ratings of 5 stars, 5 stars and 5 stars, respectively. Class N three-, five- and ten-year periods received ratings of 5 stars, 5 stars and 5 stars, respectively.
