

BBH Limited Duration Fund

Monthly Fund Update / February 2023

The BBH Limited Duration Fund Class I ("the Fund") returned 0.11% in February, and the Bloomberg 1-3 Year Treasury Index returned -0.77%.

U.S. Treasury rates rose across all tenors in February. The Federal Reserve (Fed) met on February 1st and increased the federal funds rate by 0.25% to a range of 4.50%-4.75%. The Fed's next announcement is scheduled for March 22nd. In addition, the Fed continues its campaign of shrinking its balance sheet by a maximum of \$95 billion. Mainstream fixed income benchmarks declined in February with only floating rate segments of the market experiencing gains. Spreads of shorter duration segments of the credit markets narrowed, while spreads of longer duration segments widened during the month.

Sector allocation and security selection favorably impacted the Fund's performance during the month. From a sector standpoint, the Fund was overweight to the stronger performing, shorter duration segments of the market, including asset-backed securities (ABS), loans, and high yield bonds. In addition, the portfolio had security selection contributions from its holdings of investment grade corporate bonds, high yield corporate bonds, commercial mortgage-backed securities (CMBS), and ABS. Selection of loans hindered relative performance during the month.

We continue to find attractive opportunities despite waning spreads available in mainstream indexes. During the month, we added positions in corporate bonds issued by healthcare companies, a bank, and a technology company. We initiated loans to a manufacturing company, electric utility, a healthcare company, and a midstream energy company. We also invested in floating-rate bonds¹ of a single-asset, single-borrower CMBS deal.

We believe successfully navigating markets will be predicated on identifying credits that offer appropriate compensation and demonstrable durability. We remain steadfast in applying this approach across a broad opportunity set that includes investment ideas within and beyond mainstream indexes.

¹ Floating-rate bonds are bonds that pay variable rates of interest where the coupon adjusts periodically according to a predetermined formula.

The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. The BBH Limited Duration Fund was rated against the following numbers of U.S.-domiciled Ultrashort Bond category funds over the following time periods: 215 funds in the last three years, 178 funds in the last five years, and 102 funds in the last ten years. With respect to these Ultrashort Bond category funds, the overall BBH Limited Duration Fund (Class I & Class N), received a Morningstar Rating of 5 stars and 5 stars, respectively. Class I three-, five- and ten-year periods received ratings of 5 stars, 5 stars and 5 stars, respectively. Class N three-, five- and ten-year periods received ratings of 4 stars, 5 stars and 5 stars, respectively.
