INVESTMENT OBJECTIVE

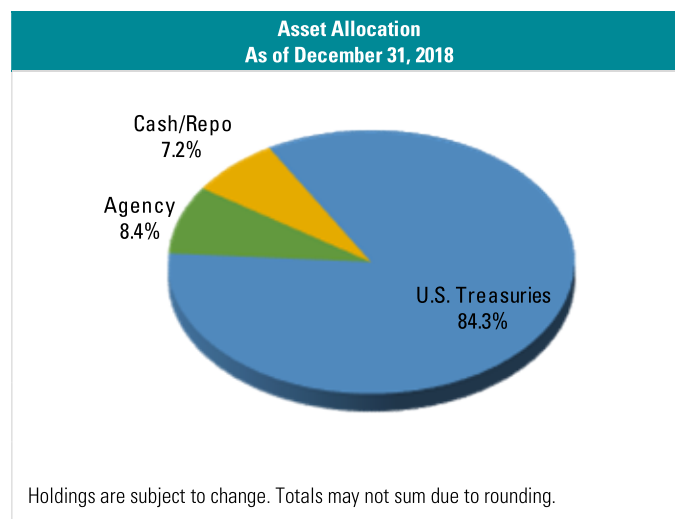
To achieve a high level of income consistent with the preservation of capital and the maintenance of liquidity.
